CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 6:30 pm.

Paslay stated that Festival of Trees would be donating \$8,000.00 to Veterans Memorial Park. Gottman thanked the committee for their donation on behalf of the City and the Veterans Memorial Park.

PRESENTATION OF AWARD TO OFFICER JAKE ETCHESON:

Chief Jeff Ray announced that Officer Etcheson completed Tactical Patrol Officer Training in November. Ray noted that Etcheson was one of the first 8 officers in Southern Illinois to complete this training. Ray and Gottman presented the Tactical Patrol Officer award to Etcheson and thanked him for his service to the City.

Paslay reported that she is working on the budget and will hopefully get those to the Department Heads this week. She also noted that Fire Chief Stombaugh asked for approval to put the old pump truck that they recently replaced out for sealed bid. She also noted that at the next meeting there will be an Ordinance for selling of surplus property. Connor will have the properties on Jefferson Street, St. Louis Avenue and Johnson Streets on the agenda at the next Council meeting.

this summer will be speaking at that meeting. Paslay will reach out to EMA and RuralMed Ambulance to see if they can attend the meeting. Bowen stated the Economic Development Director position will be reposted. The Personnel Committee reviewed the City's nepotism hiring policy and recommended to include it in the Employee handbook. This will be voted on at the next Council meeting.
